

## 2018 Philip Morris USA Shareholders' Meeting Application

- Who:** Up to four Nebraska high school students, ages 14–18
- What:** 2018 Phillip Morris USA (PM USA or Altria) Shareholders' Meeting—This unique opportunity allows youth to address corporate tobacco executives and their shareholders. Some advocates will have the ability to use proxy tickets to actually go inside the shareholder meeting and make comments/ask questions. Other youth will participate in the activism outside the meeting venue.
- When:** May 15–17, 2018
- Where:** Richmond, VA
- Why:** A training for advocates will be on May 16. Advocates will receive information on the latest tactics being employed by the industry and practice their statements for inside the meeting. Advocates who attend get to take part in planning and executing an advocacy event which are invaluable skills all advocates can put to good use in their respective communities when they return home.
- Cost:** **FREE.** No Limits will cover transportation, meals, lodging, and registration for youth to participate in the youth protests at the PM USA Shareholders' Meeting. Personal expenses, such as snacks, sightseeing, and souvenirs will be the responsibility of the youth.

#### 4) Youth Commitment

**The Philip Morris USA Shareholders' Meeting is a special event that enables Nebraska youth to build upon their tobacco prevention knowledge. There are presentations, projects, interviews and other things before, during, and after the event that youth are expected to do. Filling out and signing this application means if you are selected to attend the Philip Morris USA Shareholders' Meeting you commit to doing the following:**

- Participating in conference calls regarding attendance at the youth protest.
- Posting updates, photos, and comments on Facebook, Twitter and Instagram while at the protest.
- Keeping a video or written journal of your experience at the training and protest.
- Sharing your experience with others. Using information from the training and the experiences at the PM USA Shareholders' Meeting, you will create a presentation about the tobacco industry's current efforts and what youth can do about it. Each youth will give the presentation a minimum of five times before May 2019: once at the Tobacco Free Nebraska state conference in July or October, once at a No Limits event such as an activism summit, and three individual presentations to Nebraska youth audiences (ages 12–18). Presentations must be approved by the No Limits staff prior to giving them.
- Developing and implementing a project about the tobacco industry's marketing efforts using information from the PM USA Shareholders' Meeting Youth Protests by October 3, 2018. The project should reach a large audience, educate others, and empower Nebraska youth to stand up against the tobacco industry. Examples include: a traveling art display, a video, an activism toolkit, etc. Funds will be made available for the project.
