- Encourage youth to prepare for meetings by researching their representatives and the current issues

During the Rally:

- Join your group as they meet with their representative
- Attend and participate in all activities
- Communicate with other sponsors to see how efforts are going in other parts of the state
- Support No Limits staff and trainers as needed, as well as your youth
- Abide by the principles identified in the Sponsor Code of Conduct

After the Rally:

- Maintain contact with No Limits (especially as you continue your mini-grant activities)
- Encourage youth to follow through with plans and ideas developed at the rally

WHEREAS, sexual contact at any event or activity which occurs within the time frame of the No Limits Kick Butts Day Youth Rally is prohibited; and

WHEREAS, all water activities including, but not limited to, the use of a hot tub, Jacuzzi, or swimming pool facilities, swimming, boating, tubing, etc. at any event or activity within the time frame of the No Limits Kick Butts Day Youth Rally are prohibited; and

WHEREAS, any behavior that violates any of the laws of the United States or the State of Nebraska or any local ordinance is also prohibited; and

WHEREAS, there is a commitment to serve as a contact and resource person in my community/county/state tobacco education program; and

WHEREAS, all sponsors, groups, and individuals are expected to remain at the No Limits Kick Butts Day Youth Rally for the entire duration of event, which is being held primarily at the First Christian Church. (However, at times sponsors will be at other various locations for activism purposes and must remain at these locations with their youth.)
